Truth before reconciliation: 8 ways to identify and confront Residential School Denialism

1. Educate and Raise Awareness:

- Support Indigenous Initiatives: Attend events, workshops, and cultural activities organized by Indigenous communities. Learn directly from those who have firsthand knowledge of residential schools.

4. Hold Denialists Accountable:

- Publicly Challenge Denialism: When denialist views are expressed, respond respectfully but firmly. Correct inaccuracies and emphasize the importance of acknowledging historical truths.
- Advocate for Legal Mechanisms: Consider supporting legal measures to address denialism. <u>Urgent consideration should be given to both civil and criminal sanctions</u>.

5. Avoid Rushing Reconciliation:

- Prioritize Truth: Rushing reconciliation without acknowledging the truth undermines the process. We must confront denialism and ensure that the legacy of residential schools is fully understood.
- <u>Let's prioritize truth</u>.
