1. The conduct of the students must be orderly at all times and follow directions given by the bus driver.
2. Students shall remain in their seat while the bus is in motion.
3. Students shall sit in the seat assigned by the driver.
4. Students shall keep their heads and arms inside the bus at all times.
5. Nothing is to be thrown in the bus or out of the windows.
6. Students must not talk to the driver while the bus is in motion.
7. Students shall line up in single file to enter the bus.
8. Students shall not move toward the bus until it stops. They should not enter until the driver indicates that he/she is ready to have the bus loaded.
9. Students leaving the bus may cross the road in front of the bus if the vehicle is stationary and the RED LIGHTS ARE FLASHING.
10. Students must obey the driver's directions.
11. Any willful damage to the bus by students shall be charged to the students or their parents.
12. Eating or drinking is not permitted on the bus.
13. No harmful objects are allowed on the bus. Instruments, backpacks, etc must be contained in a seat.
14. The District Code of Conduct Policy #19 and Administrative Procedure #114 Student Conduct Standards and Behaviour Management, covering alcohol, illegal drug use and bullying apply to students on the bus and at the bus stop.
15. For the security of the students, surveillance cameras may be in operation at anytime.
16. Violation of these rules may result in the student being deprived of the privilege of bus transportation.
