Recommendation:

THAT the comments on the draft *Catchment Areas, Cross Boundary, Schools of Choice, and Programs of Choice* policy be considered;

AND THAT the *Catchment Areas, Cross Boundary, Schools of Choice, and Programs of Choice* policy be submitted to the Board for consideration at the January Board meeting.

Executive Summary:

The draft *Catchment Areas, Cross Boundary, Schools of Choice, and Programs of Choice* policy was presented to the Board for consideration in November 2016. The comments are summarized in the public consultation section. Additional amendments have been made to policy considering the development of procedures. As the administrative procedures that guide implementing the policy are in the final review stage at the staff level, they will be provided to the board with the Board Meeting Agenda.

Background:

Policies provide the direction and guidelines necessary to deliver governance and services, and information for all who may be interested in, or connected with, the operation of the School District.

A number of issues were identified with the catchment area policy. Staff have reviewed the existing policy, and are recommending the changes to the policy. The revised draft policy is presented for the Board's consideration.

Analysis and Impact:

The revised policy is expected to clarify a few issued identified with the policy during the past few years. The administrative features of the current policy will also be moved into administrative procedures. These procedures will be updated prior to final approval of the policy.

Strategic Priority:

The review aligns with the direction of the Strategic Plan to *Review, revise and create policy and committee* structures that contribute to effective governance and operational direction. Policies will be reviewed and revised ensuring transparent participation.

Policy, Regulation, Legislation:

See Current Board Policy #17

Public Consultation:

The following comments were received:

- 1. If a parent chooses to send their child to a school, be it a school or program of choice or another neighbourhood school and not their catchment school, and outside the reasonable walking distance, the parent should be responsible for the costs of getting the child to school. If the child is on SD75 buses that the parent should pay for busing the student.
- 2. Students should have the option to ride the bus if they are outside the walking distance, regardless of if they are in catchment or not.
- 3. Busing priority levels need to be looked into and that busing is not a service that should be taken for granted. There should be a priority level for students riding buses,
 - a. first priority going to students within catchment that are outside the walking distance, and
 - b. second priority to those outside the walking distance that are at a school or program of choice. Busing should NOT be free - ALL parents should pay a fee.

Staff will consider the comments for revising the Transportation policy in due course. Staff anticipates updating this policy in Spring 2017. The review will also consider the recent changes to provincial funding for busing students.

To establish guidelines for student access to public education at a neighbourhood school, a School of Choice, or a Program of Choice.

Policy

Neighbourhood schools will generally be accessible to all school-age students in the neighbourhood, subject to enrolment capacity.

Neighbourhood schools may be accessible to school-age students outside of the neighbourhood, subject to a cross boundary school application and enrolment space availability.

Schools of Choice and Programs of Choice will be available to all students in the district, subject to an application and the enrolment space availability in the School or Program.

General Guidelines

In accordance with the *School Act*, schools will enroll students in the following descending order or priority:

- A catchment area student who, in the previous school year, attended the school.
- A student assigned by the Board to the school.
- A catchment area student.
- A non-catchment area student who, in the previous school year, attended the school.
- Siblings of non-catchment area students who, in the previous school year, attended the school.
- A non-catchment area student.
- A non-school district student.

Catchment Areas

An elementary school catchment area is a specified geographic area that surrounds a school. In determining a school catchment area, consideration will be given to the walk limits specified in Board Policy, and the number of students that would be attending the elementary school. The objective will be to consider the capacity of the schools and balance the enrolment amongst most elementary schools.

Information on the school catchment areas will be provided to parents and students, with additional information and details made available on the Mission Public School District website (<u>www.mpsd.ca</u>).

The School District may amend the catchment areas as needed.



Elementary Schools

The elementary school in each defined catchment area will be the neighbourhood school for that area. Residency in the elementary school catchment area qualifies an elementary school student to attend that school.

Middle Schools

The Middle School catchments are determined to equitably distribute the student population between the two middle schools. Elementary schools are assigned to a Middle School catchment as follows:

Cross Boundary

The School District will consider cross boundary school applications for students to attend a school outside of their catchment area.

The School District will use a fair and equitable approach when considering cross boundary school applications.

Approval considerations

Applications to attend a cross boundary school will be considered when sufficient enrollment space is available at the cross boundary school.

Applications for students that have been displaced by the closure of a school will be given priority for a cross boundary school application for the school year immediately following the closure.

If approved, attending a cross boundary school will be for one school year only.



School District Cross Boundary Placement

The School District may find it necessary to enroll a student in a school other than the neighbourhood school due to the availability of special programs or enrollment restrictions. While such placements shall be expected to remain for the duration of the current school year, whenever possible students will be returned to their neighbourhood school effective the start of the next school year.

Schools of Choice

A School of Choice means a school other than the neighbourhood school that parents choose to have their child(ren) attend. The School District has two Schools of Choice. These schools are not neighbourhood schools and do not have a defined catchment area. Any student may apply to attend a School of Choice. The Schools of Choice are:

- Edwin S. Richards Arts-Based Curriculum
- Hillside Traditional Academy Curricular outcomes in an environment based on traditional values.

The School District will use a fair and equitable approach when considering applications to attend a School of Choice.

Programs of Choice

The School District offers Programs of Choice at four schools. Programs of Choice are a School District initiated program approved by the Board and designated to run in one or more school sites. Programs of Choice are offered in elementary schools as follows:

- French Immersion
 École Christine Morrison Elementary School
- French Immersion
 École Mission Central Elementary School

The elementary school Program of Choice catchment area is aligned with the neighbourhood catchment area for the elementary schools listed below. The catchment boundaries for the Programs of Choice will be reviewed annually to ensure that each school is being utilized to its potential for the regular programs and to ensure the dual-track schools meet the Board's expectations.

With experience of solar panel installation in School District No. 50 (Haida Gwaii), the Superintendent contacted and has met with Scott Fleenor, Owner, Terratek Energy Solutions Inc. A verbal report was provided at the November 29, 2016, Business Committee.

Mr. Fleenor has a wealth of experience with solar panels in BC schools. Some general information to date, includes:

- Single best candidate is Albert McMahon;
- Opening up older built schools may introduce other issues;
- 24 Kilowatt minimally; 8 KW could run a computer lab.
- 24 Kilowatt \$40,000 plus/minus depends on angle of roofing;
- S. Fleenor will provide quotes in due course;
- Solar panels can also provide positive learning interactions with students;
- Any work over \$25,000 requires an RFP;
- What does the Board wish to achieve overall? Other considerations: Ensure they are safe and remain clean.

MLA Simon Gibson has indicated a desire to assist with further exploring the possibility of solar panel installation. The Superintendent has delivered a letter in support of the initiative.

Dr Gibson:

Please find attached an initiative from School District No. 75 (Mission) to merge our efforts to go green as a cost saving measure with our educational initiatives to instil environmental values and knowledge in our students. As you are likely aware, the new BC curriculum puts considerable emphasis on citizenship, indigenous knowledge, and environmental sustainability. I hope that Mission Public Schools will encapsulate all of these values in this proposal.

Effectively, the Board of Education would like to begin a program of placing solar panels on many of our schools. Most of our schools are ideally situated with south facing slopes to capture maximum sunlight. Working with local BC providers, these panels are linked to student and staff equipment so they can measure energy intake and carbon reductions. At some sites we will also involve students in the planning and construction phases of the project. At all sites students would engage in dialogue around consumption, alternative energy, and their role in protecting their community's environment. I think you can agree this sort of initiative seamlessly blends many of the qualities we want in our communities, province, and nation.

As outlined on the following pages, I have experience with similar work on Haida Gwaii where we placed, at the time, the largest solar array on a public school in the province. Arrays range in cost from \$20 000 to \$80 000 (or more), and Mission is committed to solar technology in the coming five years.

Solar Array Initiative Overview

The purpose of this initiative is to connect students to an awareness of their consumption of energy and how changing their behaviour or the source of their energy can have a beneficial impact on their environment and the sustainability of their community and lifestyle. I have




based some of this on previous work in School District No. 50 (Haida Gwaii), where we connected a Carbon Neutral Fund with educational outcomes in a variety of grades and classes from Kindergarten through grade 11 Applied Skills. In that case, two solar photovoltaic systems (PV systems) were constructed over two years. The first was an 8kW array, built over a kindergarten classroom at Sk'aadgaa Naay Elementary. It transferred enough electricity to pay for the school's computer lab annually. The second was, at the time, the largest on a school in the province of British Columbia, at

24kW. This larger array, built at Queen Charlotte Secondary (now Gidgalang Kuuyas Naay), actually provides substantial electricity generation. The collectors' have worked extremely well, even in cloudy weather. As an example, on Saturday, June 13, 2015, a mostly sunny day but with significant cloud cover, Sk'aadgaa Naay's array generated 33.9 kWh; the larger 24kW

unit at QCSS generated 143.62 kWh. To put in perspective, that is about 20% of the electrical consumption of the school at full use. The QCSS panels save approximately \$9000 per year in electricity, and thus the project would be paid off in a matter of a few years, but is really 'found money'. The panels have a 25 year warranty, and have thus far proven hassle free.

More significantly, and a key part of our focus here in Mission, is to tie the technical piece to student learning. First, as the arrays are placed on our buildings, the contractors take time to explain to students about things like placement; too often the position of the sun and building are not take into account, or other practical energy saving things you can do in your home. Students can then collect information on daily, weekly, monthly (and even total) electricity production from their array. This can be connected to Social Studies and Science topics on the weather, the Earth's orbit, photovoltaic charging, and so on. They can even calculate the profit and/or cost avoidance of operating the array, which can be connected to math or business classes as an encouragement towards green business models.




But saving money and learning about weather patterns is really only part of the story. Readouts accessible online provide information on avoided consumption; for example, the 24kW array has prevented about 20 tonnes of carbon from being emitted (Haida Gwaii relies on oil for electricity generation), or the equivalent of traveling by car more than three times around the equator! This information can lead to dialogue in a Social Studies or even Social Justice context around how our choices impact our environment and the environment of others around us. Recent protests against pipelines, concerns over drinking water, increased activism by First Nations, and many other related issues can be addressed by considering our part in the global energy economy. It should be noted that these are not just issues of particular political bodies - organisations as varied as the military, science teams, land surveyors, and remote logging companies also seek ways to be less dependent on bringing supplies like oil from afar while functioning in remote environments. This has further implications for First Nation's communities and other rural villages. On Haida Gwaii, a series of biomass heating systems were generated from this solar panel initiative.

Finally, of course, these sorts of projects also contribute to class and community discussions on other possibilities. We have schools like Dewdney and Deroche that could explore micro hydroelectric, for example. The Board of Education sees these panels as part of an ongoing greening of both our facilities and the education of our children. The Board also envisions an LED monitor in the entrance area of schools so visitors and students alike can see real-time reporting on energy production.

I recently had a consultation visit with Scott Fleenor, Principal of one of our local BC alternative energy firms, Terratek Energy Solutions, who have been responsible for a wide range of public and private solar panel projects around British Columbia (<u>http://terratek.ca/</u>) to seek their advice on which Mission schools had the best sites for energy production. During our tour of Mission sites, he remarked at how almost all of them have excellent southern exposures. He recommended we start at the ideally situated Albert

McMahon Elementary, which is a growing school in the northern part of the District. Following this, Dewdney Elementary has an excellent roof and a rural location that would tie in nicely to its outdoor education philosophy. Other schools with ideal situations include Mission Secondary, Hatzic Middle Schools, Hillside Traditional, and Windebank Elementary.

The Board is committed to eventually covering most of our schools with photovoltaic arrays. We will enter into a request for proposals early in the new year. However, we know that while this initiative is worthwhile, it is expensive. Solar photovoltaic arrays run in the tens of thousands of dollars, and while they scale in energy production, larger is still more expensive. A 24kW system is around \$50 000, for example. It is hoped that some additional support from outside contributors would accelerate the Board's desire to get even modest PV systems at all schools within the decade. Ideally, a fund in the range of \$20-\$35 000 would kick start the Board's contribution to make this a reality during the early summer of 2017.



We are adapting the curriculum in B.C. schools so kids learn the skills they need to succeed in our changing world. This means we also need to develop a new reporting approach. Right now the progress of your child is reported in many different ways, including report cards, parent teacher meetings, and regular student/parent/teacher check-ins.

Reporting is all about keeping parents like you informed, and we want you to tell us HOW you want to be informed and keep track of your child's progress. Until February 28 next year you can submit your thoughts online at <u>engage.gov.bc.ca/yourkidsprogress</u>.

As well, community meetings will be held in 10 communities across the province over the coming months so parents can ask questions and share their input. Check the website for times and locations as they are scheduled.

The ultimate goal of this engagement is to develop a student reporting process that gives families a deeper understanding of their child's progress at school through timely and comprehensive information. We'll gather the feedback and share our plan next June.

Our education system is one of the most highly ranked in the world. Students are finding success in music, in academics, in sports – and in every subject in between. Together parents, teachers, and the education system are making sure we build on that for an even better tomorrow.

SUBJECT:	Board Authority/Authorized Self-Efficacy Course - Follow-Up

Fraserview Learning Centre Principal, Kevin Watrin, presented the course framework at the June 7, 2016 Education Committee.

The course is designed to expose students to ways in which they can develop and enhance their selfefficacy. Helping students to explore the power they have to affect situations influences both the ability a student has to face challenges competently and the choices a student is most likely to make. Learning outcomes for the course are grouped under social-emotional learning themes, focusing on the development of self- and social awareness and self- and relationship management skills. By exposing students to diverse situations and interaction, students will begin to develop personal values. Students will be exposed to strategies and skills to aid them in communication, interpersonal relations, and conflict management while taking responsibility for their decision-making and problem solving. As a culmination, students reflect on their progress and personal goals, and begin to consider how they can create new possibilities for themselves.

On June 21, 2016, the Board of Education approved the Self-Efficacy Course for implementation.

Principal Watrin, joined by educators, Sandra Norum and James Martyn return to provide follow-up on the course to date.
