#### 6) Presentation - Angus Wilson

- a) Amendments to the School Act
  - i) #1 First Nations School of Choice Policy
  - ii) #2 Model of LEA "Local Education Agreement"
  - iii) #3 Indigenous Education Council Policy
    - (1) This is a Provincial Mandate
    - (2) Some communities don't have an Advisory Council
    - (3) All School Districts must have an Indigenous Education Council
    - (4) The Indigenous Education Council must reflect the local First Nations
    - (5) Don't have a Terms of Reference
    - (6) Local First Nations would have voting rights
    - (7) Local First Nations can choose who attends meetings
    - (8) There are still some limitations
    - (9) Will take effect immediately, and it will have an impact on the 2024 2025 school year
    - (10) This has a profound impact on all Education Councils
    - (11) Our group does well with what they require
    - (12) Excited to see the official outcome
    - (13) We all have a say

- (14) There are a lot more in our School Districts besides local Bands
- (15) Hope that the School District could provide guidance but not tell Indigenous people what to do

#### 7) Financial Statements Review - Vivian

- a) SWSW Financial Statements & Overall Budget
  - i) At the end of last year, we had a projected \$156,000 surplus
  - ii) When the dust settled in Sept/Oct., it was substantially less
    - (1) It was around \$80,000
  - iii) 2 ILW's resigned on short notice and their positions won't be re-filled
  - iv) We were given \$25,000 SAFA funds:
    - (1) We won't be paying phone or hydro bills
    - (2) We have also received refurbished laptops that were given to families in need
  - v) Each school has 2 funds, Enhancement Equity Grant & School Based Funds
  - vi) We have put \$20,400 from SAFA into School Based Funds to offset the budget
    - (1) School Based Funds go towards the needs of students, food, clothing, etc so it is essentially (and has been) a SAFA
  - vii) The remaining of SAFA funds will be used sparingly
  - viii) Derek & Vivian will monitor Budget

#### 8) Information & Updates

- a) Equity PATH/Equity in Action Plans & Updates for 2023 2024 Vivian
  - i) Educator Equity Leads
    - (1) We have a group of about 20 educators that meet once per/month
    - (2) Mostly teachers but will have one Admin. & one EA join in
  - ii) Surveys to:
    - (1) Students
    - (2) Indigenous Parents
    - (3) Nation Community Members
    - (4) Members of MTU & CUPE
  - iii) Final PATH in Spring/Fall of 2024
- b) ILW Applicant Special Program Language (BC's Office of Human Rights Commissioner)
  - i) Hiring preference for Indigenous persons with Indigenous Ancestry has now been extended to ILW
  - ii) Will now be included in each posting
  - iii) The questions for an ILW interview have been revised to reflect the needs of SWSW
- c) EdPlanInsight
  - i) Moved away from AIMS
  - ii) All information in AIMS has been archived
  - iii) EdPlanInsight has been money well invested
  - iv) It is linked to MyEd BC
- d) Mission Local Immigration Partnership Council (see attached)

- e) Strategic Plan Feedback Reminder

- f) Ground-Breaking Ceremony for Metis-Based Child Care
  - i) This Child Care will be at West Heights Community School

- a) District Name Change
  - i) Doesn't need to be decided today
  - ii) Needs to go through several steps
  - iii) Invite Angus Wilson back to our next meeting
- b) HMS Memorial Project
  - i) Back in September, HMS had an idea to create a Memorial Project for the loss at St. Mary's
  - ii) Vivian will check in with progress and report back
- c) Terms of Reference Nicholas
  - i) Table this until the New Year
  - ii) As per changes to School Act (above), will affect our Terms of Reference
  - iii) We must be open minded and include the whole community
  - iv) We work well here together
  - v) It's all about our children
  - vi) We all need to work together and be on the same page

#### 10) New Discussion & Considerations

- a) Policy Meetings Potential Revision of Format
  - i) We have been having Policy Meetings for over the last year & a half
  - ii) Policies wouldn't be where they are today without you
  - iii) The past few meetings we didn't have any Nation representation
  - iv) The Policy for Indigenous Learners is very outdated
  - v) Is it better to meet on Teams or in person?
  - vi) Ours is an interactive process
  - vii) We need Indigenous input
  - viii) There is no timeline on policy
  - ix) Indigenous input is invaluable
  - x) The next Policy meeting is on December 11@ 10:00 a.m.
  - xi) Vivian is happy to meet in person if you prefer
- b) Protection of Indigenous Intellectual Knowledge Revisions to Policy 4.4 *Sto:lo History and the Halq'emeylem Language, Story, and Culture* (see attached)
  - i) Great example of how you start something & you give it time & space; you produce something like this
  - ii) Over the summer, Vivian read Jo Chrona's book (see attached for reference)
  - iii) This would protect Indigenous Knowledge & Knowledge Keepers
  - iv) Things we pass down verbally to family
  - v) It's like re-learning the whole process

- vi) Residential School survivors struggle a lot over what they learned in those schools
- vii) We have come a long way in the school system
- viii) If you want to give this to your Nations and give input, please let Vivian know
- ix) Everyone is in favour of this
